- I. GENERAL COURSE INFORMATION
 - A. **Course Description.** Prerequisites: MCHN 2433, MCHN 2437, INMT 1343, or instructor approval. This course is an advanced course in designing and building of special tools, such as jigs, fixtures, punch press dies and molds. Machining and assembling of a production tool, using conventional and advanced machine shop equipment are presented. Topics include the application of production tool theory, care and maintenance. Emphasis will be placed on skills required by local industry.
 - B. **Course Goals/Objectives:** The student will demonstrate advanced machine setup and operation; explain production tool theory, care and maintenance; define logical sequence of machining operations; explain self-managing resources (time, materials and cost); demonstrate machining to required tolerances; interpret engineering drawing and specification; perform close assembly; calculate part clearance/interference and press tonnage; and align and test related project.
